As additional information from site regarding to point #4 & #5. Pls see my info on the Blue highlight below :

- 4. We need to approach better the <u>team at the site</u>, during the discussion today it was told that Trakindo is on the max capacity at the site, regarding the maintenance capabilities, # of bays, tooling, etc and Komatsu would have more capability and room.... I pushed it back, with some arguments as the number of equip in Marc contract and so on.... but we need to understand why the <u>people at the site is in favor of Komatsu</u>.
  - <u>Maintenance Capability</u>: Today It's still many room to increase the capability on site, since we are going to support Cat Non MARC fleets, besides MARC machines. In 2019, we just have added 33 Serviceman on site (now total number serviceman on site are 136, exclude Indirect people (Support & Service supervisory level) and additional/replacement 10 units Light Vehicles (LV).
  - b. # of bays : Currently we have 8 bays, and will be added 2 more bays in this year, as commitment with Vale site/Indonesia. Meanwhile we are waiting the workshop bay execution done by Vale, Vale site provides The Petea workshop for Trakindo site to support MARC units.
  - c. We'll increase parts availability on site from 92% to 96%. Currently our parts inventory about 11K, with value about USD 13Mio.
- The intent of this tender is to replace Komatsu fleet It might explain the #4 and vale's technician preference? Does komatsu have Marc? Komatsu / UT doesn't have MARC, but they have SSA (Site support agreement).

Shan and I are speaking every day but I think is important to keep everyone on the same page...

**Shan/Aswin** what are the latest on lead time for 777 and lead time for 994? would be good to bring it for the meeting today.

## Main points to discuss:

- <u>6020</u>, discuss all alternatives since according to the tech evaluation the 6020 doesn't comply with the tender: 230 Tonnes, Not comply, beyond available <u>lowbed trailer capacity limit of 190-195Tons</u>. I heard that the site is looking for a bigger lowbed trailer capability. *Trakindo feedback*?
- 2. 777, we need to improve our lead time of Aug-2019, komatsu is offering Jun 2019... Alternatives? Rental?
- 3. <u>DPA</u> is the Incoterm that has been defined. Lets focus on this

- 7. Vale asked to keep the focus on 777, D6 and 6020.... I asked what about the 994? And he said the site has urgency on those 3 equipment.
- 8. Vale will extend the deadline (from April/2019) to reply the last email to middle of next week and we will need to <u>re validate</u> the commercial conditions and lead time, big chance that next week is the last round.

- We have the best price on the 8 x 777 but need to improve the lead time Komatsu is 60 days better
- The preferable incoterms is **DAP** at the place (mine site). All prices below are DAP.
- 6020 -\$2.2MM has better price than komatsu but not better than Hitachi EX900 \$1.95MM. Hitachi availability is April/2019 (??) and our 6020 only sept 2019. We need to put together a proposal and packed everything together to get this one, I know they have some hitachis already at the site but we need to introduce our 6020. I have asked the PG some competitiveness material
- 3x 992, \$1.9MM Feb2020 Komatsu WA800 \$1.57MM-Dec 2019
- Sales contract where we are with it?
- Not a lot of info on XCMG, but also it doesn't seems to be a threat

• Lead time is the drive. Can the Trakindo site manager check with Vale operation manager what is the real impact of 60 days difference? And influence him to support our proposal since this is a decision for the next 10 years relationship?
