PROGRAM BRIEF

Caterpillar Aggregates Pro Series training is an instructor led 5 days training program aimed at enhancing the skill and expertise of Caterpillar and dealers staff involved in sales, application, technology as well as service support to quarry & aggregates customers. Aggregates Pro replaces the **earlier offered Quarry MAPS** training program with improved curriculum concentrated around finding solutions for practical / field challenges encountered by quarry & aggregates customers.

TRAINING GOALS

Develop dealer and Caterpillar sales, application as well as support staffs in creating customer solutions around their understanding of the quarry mobile equipment operations throughout the quarry value stream. The training also provides an opportunity to keep participants updated with industry latest & relevant knowledge and expertise on quarry machine configuration, application, fleet sizing and best operational & maintenance practices that will help in enhancing the **quarry operational efficiency** and **lowers cost per tonne**.

KEY LEARNINGS

After completion of the program, participants will be able to.

- Products for quarries, configure machines based on application and material characteristics.
- Select right equipment and fleet size for each phase of quarry production value chain.
- Understanding Work-Tools and how it impacts performance of machines integrates into & impacts quarry processes.
- know ways to improve quarry operation by understanding best practices of equipment operation.
- run **VST Pro [replacing Cat® FPC Software -Fleet Production & Cost Analysis]** with live data collected from the quarry operation and prepare recommendation using the VST Pro and quarry site observations.
- learn how Caterpillar can help in making quarry safer and sustainable.

TARGET INDUSTRY SEGMENT

Program content is designed and suitable for quarry and aggregates segment which involves extraction of limestone, crushed stone / aggregates etc. for construction industry by deploying heavy earth moving machinery / mobile machinery.

- A laptop with the **registered and latest version of VST Pro software program loaded and tested**. Please note that security provisions of VST Pro access will be for people with CWS ID and access request has been approved.
- It is recommended that each dealership bring one set of Go Pro Camera, GPS Navigator and Inclinometer or clinometer which will be used during the quarry site visit.

FACULTY / TRAINER

Caterpillar System Application Specialist, Quarry & Aggregates Industry Specialist and SMEs from Product Application, Work Tools, VST Pro and Technology will be facilitating the training program.

PROGRAM COST

Caterpillar will charge fee for this training.

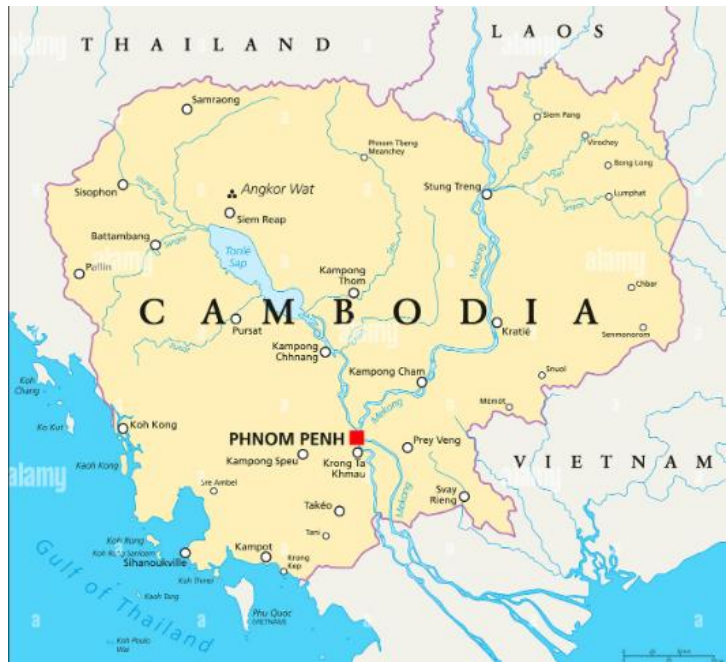



Cambodia e-Arrival Card on electronic system would consolidate immigration card, visa application form, customs form, and health information into a single form.

In this connection, the Ministry of Interior will introduce the trial period from **01 January to 30 June 2024**. During the trial period, passengers will have the option of filling out the electronic form or standard papers for immigration, customs and health information.


The official implementation of the Cambodia e-Arrival Card will begin on **01 July 2024**, with all passengers required to complete the abovementioned electronic form.
